Summary of Proceedings of the 36th Annual General Meeting

The 36th Annual General Meeting (AGM) of the Members of Shivkamal Impex Limited was held on Wednesday, September 29, 2021 at 2:00 P.M. at the Registered Office of the Company at Ground Floor, Block-P- 7, Green Park (Extn.), New Delhi - 110016.

Mr. Manu Jain, Director of the Company chaired the Meeting. The requisite quorum being present, the Chairman called the Meeting to order. The Chairman welcomed all the Members, Directors and Invitees present at the AGM. Thereafter the Chairman delivered his speech.

With the consent of the Members present at the meeting, the Notice convening the Annual General Meeting, the Director's Report and the Financial Statements for the year ended March 31, 2021 along with Auditor's Report were taken as read. Members were informed that the Secretarial Audit Report and the Statutory Audit Report does not contain any qualification or adverse remark.

The Chairman stated that the company had provided remote e-voting facility to all the members to enable them to cast their votes electronically on all the resolutions set forth in the Notice of 36th Annual General Meeting of the Company. The remote e- voting commenced on Sunday, September 26, 2021 (9:00 A.M.) and ended on Tuesday, September 28, 2021(5:00 P.M.).

The Members present at the Meeting who had not cast their votes through remote e-voting were provided an opportunity to cast their votes through ballot/poling papers.

The Chairman informed the Members that Mr. K. O. Siddiqui (Membership No. FCS 2229) of M/s. Siddiqui & Associates, Company Secretaries, New Delhi was appointed as the Scrutinizer to scrutinize the remote e-voting process and voting at the Meeting.

Members present were given the opportunity to ask questions and seek clarifications. The Chairman responded to the queries raised by the Members and provided clarifications.
