The above financial results have been prepared in accordance with principles as laid down in Ind AS-34 Interim Financial Reporting. There is a possibility that these financial results for current and previous periods may require adjustments, including those arising from new standards, modification to existing standards, guidelines/clarifications/ directions issued by RBI, Ministry of Corporate Affairs or other regulators, or changes in use of one or more optional exemptions from full retrospective application of certain Ind AS permitted under Ind AS 101.
- 2 In compliance with Regulation 33 of the SEBI(Listing Obligations and Disclosure Requirements)Regulations, 2015, a limited review of financial results of the quarter and half year ended 30th September, 2019 has been carried out by the Statutory Auditors.

As permitted under Circular No.CIR/CFD/FAC/62/2016 dated July 5, 2016 issued by SEBI, the company has opted to avail the exemption for submission of Ind AS compliant financial results and Balance Sheet for the previous year ended March 31, 2019. Consequently, Statement of Cash Flow for the comparable period has not been presented. However, the management has exercised necessary due diligence to ensure that such financial results provide a true and fair view of its affairs.

CIR/CFD/FAC/62/2016 dated July 05, 2016 read with SEBI Circular no. CIR/CFD/CMD1/80/2019 dated July 19, 2019 ("the Circulars").
